Here's how it works:

Attach QC Tags to Apron Items

QC Tags are available in two designs: plastic attachable and fabric adhesive. All tags have a unique tracking ID and barcode.

Scanning is done with a barcode scanner attached to your workstation.

Then a vinyl adhesive **annual QC indicator** is attached to show status at a glance.

Record Inspections on QC Worksheets

QC Worksheets are used to log the inspection status of each apron. Users scan the barcode on the tag to bring up the worksheet, saving data entry time. Failures, out-of-service conditions, and pictures are logged and tracked. Worksheets are browser-accessed and can be customized.

Get Email Notices When QC Is Due

QC-Track sends alerts via email when apron inspections are due or overdue, and dashboard notices are also triggered for due or overdue apron inspections. Apron departments can be on different QC schedules within a QC-Track installation.

Prove Inspection History with Reports

Reports show Inspection Status, Apron Inspection History, Apron Search, and Inspection Statistics. Reports can be generated for a department or across departments. They can be generated as PDFs to print or email.
